CEO Update

- Anne Heller shared there is over \$500K for the money market account and over \$77K in the checking account. Last month brought in over \$114K which is a \$16K+ increase when compared year over year
- Rob Hendrickson and Anne Heller signed form and funds will be transferring over to the investment account
- Funds donated from Suncoast Credit Union are going toward the mental health series this week was a session on self image. Great attendance and level of engagementfrom the student. The students can earn 1 hour of community service time by attending.
- Successful mentor townhall last month
- Javar Baity was nominated to be the Lakewood Ranch Business Alliance Young Professional of the year
- November 16th ceremony for Manatee Chamber's 41st Annual Small Business of the Year Awards Nonprofit of the Year. TSIC Manatee is a finalist.

- Brought in 20 of the 65 new students (mentees); the application process is year round; male population is increasing; seeking more male mentors. 3 new students from lincoln memorial
- Added 2 new donors last month with Medallion Homes as a new corporate donor
- Peace of mind inspection is able to provide us an online store for the TSIC website and there will be a fundraiser kick off; we can buy merchandise at cost and get to keep the margin
- Now have 2 grant writers
- Received \$2500 from Manatee Community Foundation; Submitting grant for Bishop foundation asking for \$100,000

Committee Updates

• For the Finance Committee Update, Ray Vicks, reviewed the financials and advised we continue to be in a strong position compared to last year. Prepaid tuition is up \$300K over the last quarter. When reviewing the P&L statement, the 4010 individual contributions went up more than 50% last quarter.

- Teena Johnson shared a demo of the new Mentor Hall of Fame now on the TSIC website
- Rob Hendrickson presented moving towards Full Board Committee Participation. He asked board members to consider their committee interests and think about where we have gaps that can be fulfilled through a committee. It was brought up that there is a growing need for mental health awareness/support for our students.

- Ray Vicks will be vacating his role and search is on for a new Treasurer
